This is your application and contract for participation as a food vendor at the Laredo International Fair & Exposition, which will be held February 24th – 27th , 2010. If you are interested in participating in this event, complete this application and contract. The deadline for submitting the application will be February 19th 2010. An incomplete application will not be accepted. LIFE reserves the right to refuse any application. All rules & regulations are subject to change without notice.

Two tokens (.50 & \$1.00) will be available for purchase by person attending the fair. All tokens will be collected every 4 hours to audit vendor sales. Vendors shall count all tokens before turning them into the finance office. Only tokens shall be accepted for vendor sales, any vendor accepting cash or selling unlisted items will be escorted from the L.I.F.E. grounds, forfeiting their \$50.00 deposit.

L.I.F.E. will retain 25% of the total gross sales from each food vendor. Checks will be distributed two weeks after the last day of the fair. No exceptions. In order to secure your position for L.I.F.E. Fair a \$50.00 refundable deposit per booth is required.

#### RULES & REGULATIONS:

1. Tokens must be counted before you turn them in.
2. Vendors must sign from acknowledging the counted tokens
3. Vendors can not accept cash
4. Vendors may give change only in tokens
5. Vendors can only sell items listed on contract
6. Vendors are prohibited from selling the following items :

7. Vendors must provide proof of insurance, or insurance is available for an extra \$50.00 at L.I.F.E.
8. Vendors must be on hand selling products for full duration of fair Wednesday, Thursday, Friday & Saturday.
9. Vendors must be set up every morning by 8:00 a.m. No vehicles allowed in past 7:30 a.m.
