2. Exhibitor must provide own tables, chairs, backdrops, electrical extensions additional lights, etc.
3. Booths are electrical outlet accessible. Note: Electricity will be provided between the hours of 8:00 a.m. to 10:00 p.m. . If overnight power is required, an additional charge of \$50.00 will be assessed.
4. L.I.F.E. reserves the right to RESTRICT and REMOVE exhibit that is offensive or interferes with the overall operation of the exhibit barn.
5. Booths will be assigned by the Exhibit Barn Coordinator and by application request (given requested space available). Payment of booths must accompany the application to reserve the space.
6. All booth space will be paid in advance and is NON – REFUNDABLE. There will be NO EXCEPTIONS.
7. Set up Date: Tuesday, February 26th from 8:00 a.m. to 4:00 p.m. Remove date is Sunday, March 2nd by 12:00 noon. Exhibit Barn will close at 12:00 midnight on Saturday, March 1st If you would like to leave before that time you may do so, if not you may pick up your items on Sunday, March 2nd from 8:00 a.m. – 12:00 noon.
8. Operating hours 8:00 a.m. to midnight
9. Booths should be kept neat and in good condition at all times.
10. No cars, trucks, recreation vehicles, or other motorized vehicles will be allowed on the Festival Grounds after set up date. Once your products are unloaded, your vehicle is to be moved to your designated parking area.
