

60th Annual Laredo International Fair & Exposition Food Vendor Application

Fair Dates: February 27 – March 04, 2023

The deadline for submitting the application and **50% deposit** is **December 1, 2022**. The remaining balance must be paid by **January 27, 2023**. Selection of booths is on a first come, first serve basis.

> Booth availability: Spaces are approximately 20' x 30'

> > Lots 1 - 16 - \$2,000.00

- Set up Date: Sunday, February 26, 2023 from 12:00 noon 5:00 p.m. or Monday, February 27, 2023, from 8:00 a.m. to 4:00 p.m.
- **Removal Date:** All Vendors must remove their property on Sunday, March 4th, 2023, between 10:00 a.m. 2:00 P.M.
- Fee is for all 5 days of the Fair. Anyone caught dumping used oil/grease on the ground will be BANNED
- Each Food Vendor will be receiving 4 passes for the week of the fair
- An additional \$200.00 fee will be added to anyone needing additional electricity (220) besides a regular 110.
- Liability Insurance is **REQUIRED**. Please provide proof of insurance with application. Should your business not have Liability Insurance, please contact Cubriel Insurance Agency at 956-568-5290 or in person at 6010 McPherson Rd to purchase an Event Liability Policy (approx. cost \$250 for the week).

- Vendors can only sell items listed on their respective contract.
- Vendors are prohibited from selling the following items:

* Frito Pies * Bottled Water * Beer

* Corn in a cup * Sodas * Pickles

- * Nachos * Coffee * Hot Dogs
- Prohibited Items: Prohibited items include weapons of any sort, illegal substances, bicycles, motorized bicycles, Segway's, skateboards, roller skates/blades and pets. No video cameras or recording devices of any kind are allowed in the Laredo International Fair & Exposition.
- All Exhibitors/Vendors and their staff will be required to sign a "Release of Liability and Indemnity Agreement." This must be done at time of check in at the L.I.F.E. Office. If additional staff arrives on the grounds after Tuesday, March 2nd it is the Exhibitor/Vendor responsibility to make sure that the staff person comes to the L.I.F.E. office to sign the "Release of Liability and Indemnity Agreement."
- Grounds Passes: Exhibitors/Vendors will receive admission passes at check-in. Each Food Exhibitor/Vendor will receive four (4) Fair Lanyards. Additional lanyards can be purchased at the LIFE office at the set weekly price.

PLEASE MAKE CHECKS PAYABLE TO L.I.F.E. CREDIT CARDS ACCEPTED WITH 3% CONVENIENCE FEE.

***It is the responsibility of the Vendor to ensure that their booth is always staffed during the fair hours of operation. The Laredo International Fair & Exposition has the right to revoke the contract and remove the booth from the property if hours are not complied with. These vendors will be banned from future events. ***
